

MEMORANDUM OF UNDERSTANDING

Academic and Research Collaboration

Between

Sandip University, Madhubani, Bihar, India

And

Nalnil Welfare Foundation, Khagaria, Bihar, India

This Memorandum of Understanding (MOU) entered into the Agriculture, Extension, Education and Research activities in the year 2023.

BETWEEN

Sandip University, Madhubani (herein after referred to as SUM), represented by Dr. Sameer Kumar Varma, Vice Chancellor, Sandip University, Located at Sijoul, Madhubani, Bihar – 847235, which expression shall, where the context so admits, be deemed to include its successors, executors and administrators of the **ONE PART**

AND

Nalnil Welfare Foundation, At-H.No: 438, Ward no: 15, Marwari Mohalla, Gogri Jamalpur, Khagaria, Bihar, India, represented by its Officer-in-charge, Khagaria, Bihar, India which expression shall, where the context so admits, be deemed to include its successors, executors and administrators of the **OTHER PART** and will collectively referred to as the "Parties".

As per the mutual discussion and agreed, both the Parties have decided to enter into this MOU for the aforesaid objectives on the terms and conditions as mentioned hereunder:

A. OBJECTIVE AND SCOPE

The objective of this MoU is to set out the framework within which Sandip University and Nalnil Welfare Foundation, Khagaria, India will jointly work towards promoting excellence in the field of Agricultural activities and education as described in the points mentioned below:

Each party shall have the right, in its sole discretion, to determine how it will fulfill its obligations hereunder. This Memorandum of Understanding has been signed with objective of:

- a. To recognize the mutual interest in the fields of research, training, development and dissemination of knowledge.
- b. To recognize the importance of the organization within its field of expertise.
- c. Summer Internship is an important aspect of the academic programme. The students of University will get exposure for the Internship in your organization which will be mutually beneficial for students and the organization.
- d. To provide a platform where experts from the organisation / University and students come under one roof.

B. This MOU will enable the parties to:

1. FOSTER research collaboration between Sandip University, Madhubani, Bihar, India and Nalnil Welfare Foundation, Khagaria, India.
2. SET the ground for longer-term University co-operative partnerships for internships, Guest lectures and skill development.
3. PROVIDE University access to organizational environments for applied and problem-based research activities.

C. Article II Scope of Collaboration

1. Joint organization and research activities.
2. Exchange of visiting experts for the purpose of conducting research at our University and your organization.
3. Discussion for the exchange of facilities and infrastructure for collaborative or independent research based on the policies of both entities.
4. Exchange scholarly information including research papers, indices to theses, books and magazines on relevant subjects and potential joint projects whenever possible and appropriate.
5. Extend invitations for attending scholarly, technical and managerial meetings as well as national and international conferences.
6. Students will be provided summer and winter internships/projects from your organization and University will allow the body to conduct the campus recruitment.
7. Consultancy cell of the University will provide training on various aspects for improving the efficiency of the employees of your organization.

D. CONFIDENTIALITY

1. Both parties agreed that information obtained in carrying out the objectives shall be kept confidential, unless decided to disclose, with mutual agreement.

E. VALIDITY

1. This MOU will come into force upon affixing of the signatures of the representatives of the partner institutions and will remain in effect for three years. This MOU may be renewed upon its expiry, with the agreement of both partner organizations.

F. DISPUTES

In case disputes arise in implementing the MOU, these shall be resolved amicably by mutual consultation only.

G. TERMINATION

1. Either party may terminate this MoU with due notice of 1 months, if the objectives cannot be achieved. In the event of termination, any information gained from either party by the way of technical processes and procedures in any published or verbal format shall be bound by the confidentiality agreement.

H. MISCELLANEOUS

1. Neither Party shall use or publicize the MoU in such a manner as to cause any disrepute to the other party and shall not make any statement relevant to this MoU which may reasonably be considered to be misleading.

I. TERMS AND CONDITION

1. This MOU may be amended, renewed and terminated by mutual written agreement of the institutes at any time.
2. This MOU is not intended to and does not create any right, benefit, or trust responsibility, substantive or procedural, enforceable at law or equity, by either party, its officers, employees or agents against the other party, its officers, employees, or agents.
3. Nothing in this MOU obligates either party to commit or transfer any funds, assets, or other resources in support of projects or activities between the parties unless expressly stated in this agreement.
4. The activities of this MOU must be carried out in accordance with appropriate rules and regulations of University and the organization.
